SUBJECT: **APPROVE THE SECOND AMENDMENT WITH PEREGRINE TECHNOLOGIES, INC. FOR PEREGRINE PLATFORM SOFTWARE SERVICES**

Dear Board Members:

RECOMMENDATIONS:

Approve the second contract amendment (Procurement Contract No. 26492) with Peregrine Technologies, Inc (Principal: Rob Wheeler, Chief Operating Officer; Location: San Francisco), for Peregrine platform software services, increasing the contract amount from \$686,500 to \$1,409,500 (\$723,000 increase), extending the current contract term of 1/1/24 – 3/15/26 by two years to retroactive term ending 3/14/28.

DISCUSSION/SUMMARY:

On January 23, 2024, Item No. 33, your Board approved a contract with Peregrine Technologies, Inc. (Peregrine) for the contract period 1/1/24 –3/15/26, for the purchase of Peregrine platform software services. On July 8, 2025, Item No. 75, your Board approved a first contract amendment with Peregrine for the integration of three additional data sources into the Peregrine platform. Peregrine developed an integration platform specifically for law enforcement and public safety. The platform consists of advanced data analytics software which interprets and manages the constant flow of critical data that originates from various databases. The Alameda County Sheriff's Office (ACSO) utilizes various database systems that are essential in completing daily work functions. The Peregrine platform increases efficiencies by turning large amounts of raw data from various databases into actionable information. Examples of data that are analyzed include: case records, calls for service, custody records, digital evidence from body worn cameras, and CAD/RMS data. The information output from the Peregrine platform provides personnel in the field with enhanced real-time data analysis as they respond to events as they happen. Peregrine's platform also provides the ability for secure collaboration and sharing of data within ACSO, as well as other partner agencies that utilize the Peregrine software platform. Peregrine's platform unifies and secures all the data output, helping our personnel to work more effectively while protecting the privacy of our citizens and building public trust.

This agreement has been approved, as to form, by County Counsel and Peregrine.

SELECTION CRITERIA/PROCESS:

ACSO has identified a vendor, Peregrine Technologies, Inc., that specializes in data integration software services designed for law enforcement agencies. Several local law enforcement agencies utilize the Peregrine platform for their data needs.

ACSO worked with the General Services agency (GSA) and the Office of Acquisition Policy (OAP) to obtain a Sole Source and a SLEB waiver for this procurement process. On March 4, 2026, GSA-Procurement issued a finding memo noting that this was an approved exception under Section VI. Non-Competitive Procurements-Item A. Single Source of Supply and therefore issued Sole Source No. 11706. On March 5, 2026, OAP approved SLEB waiver No. 10681, which is valid until 3/14/28.

FINANCING:

No additional appropriation is required. The cost associated with this contract is included in the Sheriff's Office FY 2025-26 approved budget and will be requested in subsequent years. There will be no increase in net County cost as a result of your approval.

The second contract amendment with Peregrine Technologies, Inc. for Peregrine Platform software services meet the 10X goals pathways of a **Crime Free County** in support of our shared vision of **Safe and Livable Communities**.

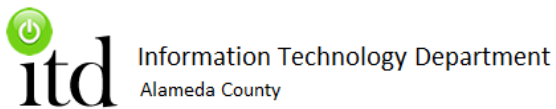



SECOND AMENDMENT TO STANDARD SERVICES AGREEMENT

This Second Amendment to Agreement (“Second Amendment”) is made by the County of Alameda (“County”) and Peregrine Technologies Inc. (“Contractor”) with respect to that certain agreement entered by them on January 31, 2024 and that certain First (July 8, 2025), Amendment to Agreement, (collectively referred to herein as the “Agreement”) pursuant to which Contractor provides Peregrine platform software services to County.

County and Contractor, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, agree as follows:

1. Except as otherwise stated in this Second Amendment, the terms and provisions of this Second Amendment will be effective as of the date this Second Amendment is executed by the County (“Effective Date”).
2. The term of the Agreement is currently scheduled to expire on March 15, 2026. As of the Effective Date, the term of the Agreement is extended through March 14, 2028.
3. The County wishes to exercise its option to extend the Term of the Agreement until March 14, 2028, as set forth under Exhibit A, Peregrine Customer Order Form & Scope of Services (“Exhibit A”).
4. In consideration for Contractor’s additional services, the County shall pay Contractor in an additional amount not to exceed Seven Hundred Twenty-Three Thousand dollars (\$723,000.00). As a result of these additional services the not to exceed amount has increased from Six Hundred Eighty-Six Thousand Five Hundred dollars (\$686,500.00) to One Million Four Hundred Nine Thousand Five Hundred dollars (\$1,409,500.00) over the term of the Agreement and any amendments.
5. Paragraph 20 of the Standard Services Agreement has been amended by changing the shall not exceed amount in the last sentence to \$1,409,500.00.
6. Item 3 of Exhibit B is deleted and replaced with the following:

Total payment under the terms of this Agreement will not exceed the total amount of \$1,409,500.00. This cost includes all taxes and all other charges.

7. Attached hereto is Exhibit D-2, *a current* Debarment and Suspension Certificate executed by Contractor.
8. Attached hereto is Exhibit F-2, THE IRAN CONTRACTING ACT (ICA) OF 2010 For Procurements of \$1,000,000 statement executed by Contractor.
9. Except as expressly modified by this Second Amendment, all of the terms and conditions of the Agreement are and remain in full force and effect.

**COUNTY OF ALAMEDA
THE IRAN CONTRACTING ACT (ICA) OF 2010
For Procurements of \$1,000,000 or more**

The California Legislature adopted the Iran Contracting Act (ICA) to respond to policies of Iran in a uniform fashion (PCC § 2201(q)). The ICA prohibits persons engaged in investment activities in Iran from bidding on, submitting proposals for, or entering into or renewing contracts with public entities for goods and services of one million dollars (\$1,000,000) or more (PCC § 2203(a)). A person who “engages in investment activities in Iran” is defined in either of two ways:

1. The person provides goods or services of twenty million dollars (\$20,000,000) or more in the energy sector of Iran, including a person that provides oil or liquefied natural gas tankers, or products used to construct or maintain pipelines used to transport oil or liquefied natural gas, for the energy sector of Iran; or
2. The person is a financial institution (as that term is defined in 50 U.S.C. § 1701) that extends twenty million dollars (\$20,000,000) or more in credit to another person, for 45 days or more, if that person will use the credit to provide goods or services in the energy sector in Iran and is identified on a list created by the California Department of General Services (DGS) pursuant to PCC § 2201(b) as a person engaging in the investment activities described in paragraph 1 above.

By signing below, I hereby certify that as of the time of bidding or proposing for a new contract or renewal of an existing contract, neither I nor the company I own or work for are identified on the DGS list of ineligible persons and neither I nor the company I own or work for are engaged in investment activities in Iran in violation of the Iran Contracting Act of 2010.
