## **Brainstorming**

**Priorities:** 

- Youth need more recreation activities
- Involve infrastructure people in general plan meetings (public works and planning need to be on same page)
- Coordinate effort to change tax code
  - Can't rely on sales tax (encourages big box stores)
  - Focus on freeways because need to draw regional buyers
- Create follow-up groups after today

#### Other issues:

- Share information on where the money is and how to get it. Give feedback to funders.
- Push for aggressive countywide green building ordinance (DOE EIA). Coordinate with all cities. Non-compete clause for Alameda County
- When you engage the community and have the money, the process goes faster. Demand more funding for planning departments from development or cars.
- Add public health and greenhouse gases to general plan
- CEQA reform is not an efficient tool
- Have like agencies with regional agencies overseeing meeting/discussions
- Look at role of compact development/land use. People need to realize how hard targets will be to achieve
- Need to educate and reach out to communities about infill development.
- Proactively work with public health/trans/other groups to find solutions on a regional level
- Connect people and communities between BART stations (bicycles, shuttles)
- Zoning
- Technology to fix problems

#### **How We Can Collaborate**

#### Top Priorities for Action

- How to comment on SB375
  - o coordinate issues and response
- Smart parking planning with city planning directors

- o Program: Cool Neighbors (transportation demand management)
- Need to augment transit in coordination with land use (to facilitate alternative commutes) (e.g., BRT)

#### Other Issues

- How to conduct public engagement to accept higher density?
- Green business ordinance city/county-wide
- How to use the stimulus package?
- Electric vehicle planning... where the plug in infrastructure will be located

#### **Top Priorities for Process**

Agreement to use existing meetings rather than convening this group

Important to involve key stakeholders across the disciplines: a more holistic, interdisciplinary approach bringing all the experts to the table- not just planners or engineers. Perhaps Transform could help facilitate this

### Other options:

- Feed into the existing regional SB 375 development discussions (3<sup>rd</sup> Fridays of the month via Joint Policy Committee) discuss framework
- E-mail group to share ideas
- Ad hoc focused topic area groups with a different set of appropriate players depending on the topic
- Regular meetings (less liked)
- Don't make the commitment open ended focused and targeted forum for exchanging ideas
- Involve young people
- Share ideas and a letter from each meeting / group get together that outlines the groups position / recommendations
- Other related groups: CA League of Cities, SoCo Green Building, Planning Director

## **Next Steps**

Chris Bazar (Alameda County), Garrett Fitzgerald (City of Oakland) and TransForm were interested in talking on the phone about the potential for working together in the future. Stuart Cohen agreed that an intern from Transform could give several hours to help coordinate.

By putting together topic areas, then staff can self-organize based on the topic and who is the most appropriate person to be involved. Also important to ensure that planning directors and others discuss these topics during regular meetings.
